**Please Note** Eisenhower Health strongly encourages/recommends you to speak with your tax advisor regarding any art donations. Per IRS Regulations, gifts of art exceeding \$5,000 require the donor to obtain a qualified appraisal within the past sixty (60) days, and complete an IRS Form 8283 to claim a tax deduction. For art valued between \$501 to \$5,000, the IRS requires the donor obtain a receipt plus a contemporaneous written acknowledgment from the charity in order to claim a tax deduction, and the donor must file an IRS Form 8283 with their tax return. For art valued between \$251 to \$500, the donor is required by the IRS to obtain a receipt plus a contemporaneous written acknowledgment from the charity to claim a tax deduction. For art valued at less than \$250, the donor must obtain a receipt from the charity to claim a tax deduction.

**Please speak with your tax advisor to review the tax deductions that may be available to you, Eisenhower Health does not provide tax, legal or accounting advice. This form has been prepared for informational purposes only, and is not intended to provide, and should not be relied on for, tax, legal or accounting advice. You should consult your own tax, legal and accounting advisors regarding any art donations.**

Please additionally note if the donated fine art is sold within three years of receipt by Eisenhower Health, then Eisenhower Health is required by law to notify the IRS and donor by reporting the sale amount of the fine art.
